The Government of Punjab vide its notification No. F-150/50 dated 28.2.1952 declared 654.00 hac. (1635 acres) area of Government Protected Forests of Bir Motibagh as Wildlife Sanctuary. 1. The Committee shall render advice on measures to be taken for better conservation and management of the sanctuary including participation of the people living within and around the Sanctuary.
2. The Committee shall regulate its own procedure including quorum.
3. The ex-officio members mentioned at Sr. No. 5 and 6 shall be nominated for only two years.
4. No T.A./D.A. shall be paid to the members of this committee for performing their duties as members.
5. The Committee shall meet at least once in a three months and will submit its report to Chief Wildlife Warden, Punjab.
