NOTIFICATION

No. 34/10/2017-Ft-5 1057481/1 Chandigarh, dated the 5/9/2017

Whereas the Government of Punjab is of the opinion that due to its ecological, floral and faunal significance for the purpose of protecting, propagating and developing wildlife and its environment, the area mentioned in the following schedule should be declared as Conservation Reserve.

Now, therefore, in exercise of powers conferred under Section 36-A of the Wildlife (Protection) Act, 1972 as amended from time to time, the Governor of Punjab is pleased to declare the area of village Garhbagha, Bahadurpur, Katli, Khuaspura, Mianpur and Haveli Kalan, District Roopnagar, totalling to 521.12 Acre as **Ropar Wetland Conservation Reserve** from the date of issue of this notification. The provisions of sub section (2) of Sector 18, Sub Section (2), (3) and (4) of section 27, Section 30,32 and clauses (b) and (c) of Section 33 of the Wildlife (Protection) Act, 1972 as amended from time to time shall also apply to the Conservation Reserve being notified. Boundary detail of the Conservation Reserve shall be as under:-

- In the North village Patial**
- In the East Satluj River Band**
- In the South down Stream of barrage, village Haveli Kalan**
- In the West diversion channel adjacent to Ropar-Nurpur Bedi Road.**
